





# **Dharmic Manifesto** for General Elections 2019

Vote for Conservative Party in all constituencies, except where the MP has expressed support for the creation of Khalistan by signing petitions, with the intention to partition India again.

It is absolutely urgent for members of the Dharmic community to register to vote and opt for a postal ballot if they are unable to cast their vote personally. And, most of all, to cast their votes, as other communities do because if votes are not cast politicians will ignore you.

Do not vote for any other political party since all of them support legislation demonising the Dharmic community by citing manufactured evidence on alleged caste discrimination. All these political parties, including and especially the Labour Party as well as the Lib-Dems, the Green Party and the SNP also support measures to prohibit fictitious Islamophobia allegations. Policies to curb alleged Islamophobia are particularly targeted at the Dharmic community, and deny them the right to their history, since resolutions being adopted by political parties denounce asserting Islam conquered by the sword or that minorities are oppressed in Muslim-majority countries. In addition, all these political parties seek to dismember and destroy the Republic of India by supporting separatist movements and recent policy statements of some political parties are supportive of Jihadi Pakistani claims over the sovereign Indian territory of Jammu and Kashmir.

The recommendation to support the Conservative Party in the forthcoming general elections on December 12th is entirely due to the dire threat posed by all other British political parties towards the interests of Britain's Dharmic communities, their welfare and physical security.

The Labour Party, Lib-Dems, the SNP and Green Party routinely fail to condemn even actual physical violence towards them let alone threats to commit such crimes. But no political party is to be trusted until MPs depend on Dharmic votes for their political survival because even the Conservative Party has behaved in a suspect way towards Dharmic voters.

The Conservative Home Secretary, Priti Patel, allowed a second demonstration on Jammu and Kashmir to proceed outside the Indian High Commission, on the 6th September 2019, despite the violence earlier of Pakistani and Khalistani Jihadi thugs towards the young and old celebrating Independence Day at the Indian High Commission on the 15th August 2019.

This shocking violence had occurred yet again despite a solemn promise by Prime Minister Boris Johnson to Indian Prime Minister Narendra Modi that such incidents would not be allowed to happen. Prime Minister Boris Johnson also allowed his UN ambassador to conspire with India's sworn enemy, China, in an attempt to issue a statement on Jammu and Kashmir embarrassing to India, though it was turned down by other members of the UN committee.

This is why support for the Conservative Party cannot be unconditional and specific demands are being outlined below, on behalf of the Dharmic community, to recommend it vote for the Conservative Party on the 12th of December 2019.

#### Part 1

- 1. The provision applying the Equality Act 2010 to alleged caste discrimination in the UK, which is demonstrably false and a hostile act fostered by evangelists, must be removed, and in a manner that expunges the effects of staged case law.
- 2. End to all support for evangelical activity aimed at religious conversion of members of the Dharmic community, which is rife in parts of the UK, impacting the entire Nepali community. Promoting religious conversion of the Dharmic community in the Indian subcontinent must also cease.
- 3. Firm commitment to repudiate any form of prohibition of alleged Islamophobia and protection against sanctions threatened by Labour councils that have passed resolutions condemning alleged Islamophobia. And a ringing declaration endorsing Britain's unequivocal commitment to free speech and freedom of conscience.

- 4. Review of board level of appointments of members of the Dharmic community in public companies and their disturbing failure to appoint its members.
- 5. Review of the serious discrepancy in appointing members of the Dharmic community by media houses like the BBC and other professions like the judiciary. Their actual numbers in the legal profession do not correspond at all to appointments in the higher judiciary.
- 6. Revamp of the EHRC which is merely an insulting gatekeeper to restrain complaints of alleged racial discrimination. The creation of a body that genuinely seeks to prevent racial discrimination, which remains widespread and is apparently being managed through duplicitous public relations exercises.
- 7. A halt to the practice of subverting the Dharmic community by sponsoring front organisations, which are actually controlled by political parties and the authorities, showing only contempt for the community. Cessation of secret contacts with supposed Dharmic community leaders who have been manoeuvred into leadership positions and disbursement of financial inducements to them to engage in behaviour inimical to the interests of the community.

The Dharmic community also wishes to advance economic and social policies affecting wider issues in society. Policies supported by the Dharmic community express preference for traditional attitudes that place emphasis on virtues with less undue preoccupation with rights.

The Dharmic community wants specific policies that protect the family and sustains entrepreneurial activity, those engaged in the economy and volunteers in every type of selfless and courageous involvement.

#### Part 2

- 1. Urgent and wide-ranging re-think of taxation and associated policies that should be designed to encourage traditional families to remain intact and flourish.
- End of public support for families that wish to have more than two children and amendment of human rights laws to make that possible.
- 3. Need for priority to be given in public housing to residents who have long association with the area in which they live. The resumption of a vigorous public house building programme to ensure affordable housing for the working poor. Specific, legally enforceable injunctions on the allocation of council housing which has often become irredeemably corrupt.

- Extension of the inheritance tax limit, scheduled to reach £1 million in 2020, to all assets in order to remove vexatious anomalies that are impacting the housing market negatively.
- 5. Financial penalties to be imposed on misuse of the NHS and especially the emergency services after a second episode of egregious behaviour, like injury due to drunkenness, some driving offences (the latter cost collected from the insurer) etc.
- Reorientation of education spending to favour nursery and primary education to create a firm basis for learning capacity in early stages that is especially effective when education is initially imparted.
- 7. Lowering the interest charged on higher education student loans to the rate of inflation, preferably the WPI, or the Bank of England base rate. Review of the longterm sustainability of student loans since they have had unexpected economic implications for both the student debtor and the public exchequer.
- 8. Renewal of support for affordable public transport that is both good economics for society as a whole and environment friendly.
- Cessation of foreign military adventures of the kind authorised by former Prime Minister Tony Blair Labour in Iraq that resulted in devastation and chaos and the continuing requirement of parliamentary approval before engaging in military action abroad.
- 10. A deputy prime minister designated to coordinate between government departments to prevent individual departmental budgetary considerations resulting in avoidable excessive overall spending. For example, appropriate spending on social services can reduce much greater resource misallocation by the NHS or enhanced funding of some forms of special education needs can significantly reduce an mis-spend by social services.

The demands of the Dharmic community, outlined in Part 1 of the Election Manifesto, are non-negotiable and it intends to field candidates in key marginal constituencies in a future general election to assert its ability to determine electoral outcomes.
